WEPA : Water Environment Partnership in Asia

- The Japanese Ministry of the Environment proposed the initiative at the 3rd World Water Forum in March 2003.
- Registered in the “Portfolio of Water Actions” (PWA), an outcome of the ministerial conference of WWF3. The initiative is registered as a regional action in CSD- WAND (CSD Water Action Network Database)
- WEPA started in April 2004 and will finish in March 2009.

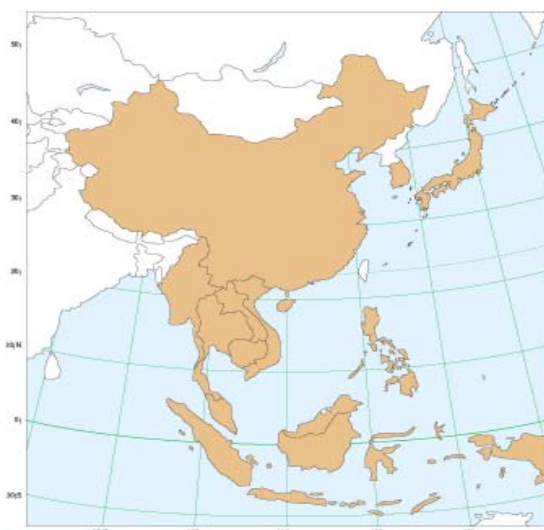
Objectives of WEPA

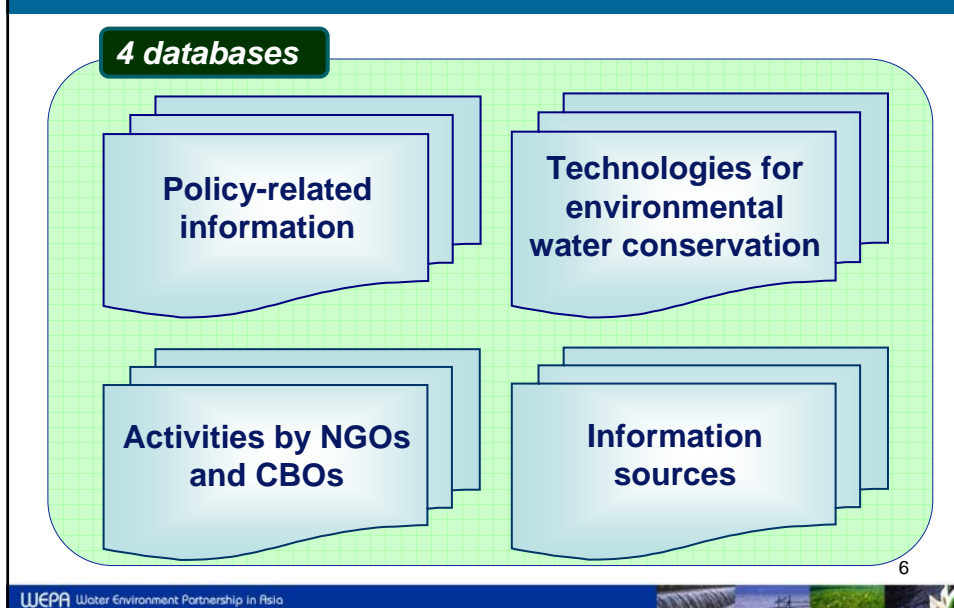
Principles of WEPA database development

4 categories of information in the WEPA DB



WEPA - benefits

- Re-evaluation of policy responses during the information gathering and reconstruction for the database.
- Promotion of information exchange with other countries, which will be useful for policy making
- Development of networks among domestic institutions and overseas organizations, which will be promoted further to acquire more useful information
- Enhancement of capacity of the staff in charge through collaborative work through WEPA activities, such as database development, international forum, and dialogue.
